

# ABSTRACT

## STUDIES

Sílvia BOQUER, Luis GONZÁLEZ, Oriol MERCADAL, Teresa RODON, Laura SÁENZ, *The Early-Mid Bronze Age structures at the Can Roqueta archaeological site (Sabadell, Vallès Occidental)*.

At the beginning of this century the site of a crematorium was found. Consequently, when the construction of an industrial estate was planned in the area an archaeological study of the building works and infrastructure was carried out in 1989. Of the eight structures discovered, two belong to the Early-Mid Bronze Age. They had been dug in the subsoil and once exposed these structures were found filled with pottery, stone and bone fragments. One of them contained two graves.

Núria JUAN-MUNS, Montserrat OLTRA and Esther PLANAS, *Archaeological survey of the Ripoll river basin*.

These surveys were a part of the programme of archaeological investigation carried out in the upper and mid sections of the Ripoll river basin. The aim was to see if there had existed Iberian sites. The programme distinguished three kinds of sites: isolated remains, places with abundant surface materials, though without visible structures, and sites with visible structures. The work carried out on the first type of site produced no evidence of Iberian settlements in the places surveyed.

Jaume PUIG I CASTELLS, *Precedents for planned urban expansion in Sabadell*.

The birth of modern town planning is identified with urban industrialization. At the same time it is affected by various techniques and ways of doing things that have an earlier origin. In this article this tradition is demonstrated with reference to the urban rules and regulations that, before the middle of the last century, determined various guidelines for later urban growth projects.

Manuel MARÍN, *Electoral tendencies in Sabadell in 1931*.

A study of the two democratic electoral contests in 1931:

the municipal elections of 12th April 1931, which led to the proclamation of the Republic, and the elections for the Constituent Parliament on 28th June. This analysis demonstrates that the social structure was decisive compared to other factors (illiteracy, religious practice, age, political-economic circumstances, canvassing...) in affecting the way people voted.
