

ON THE STRUCTURE OF THE INTERSECTION OF TWO MIDDLE THIRD CANTOR SETS

Abstract

Motivated by the study of planar homoclinic bifurcations, in this paper we describe how the intersection of two middle third Cantor sets changes as the sets are translated across each other. The resulting description shows that the intersection is never empty; in fact, the intersection can be either finite or infinite in size. We show that when the intersection is finite then the number of points in the intersection will be either 2^n or $3 \cdot 2^n$. We also explore the Hausdorff dimension of the intersection of two middle third Cantor sets as the sets are translated across one another. We show that the Hausdorff dimension of the intersection can take on any value from 0 to $\ln 2 / \ln 3$; in addition, we show that for each Hausdorff dimension, between 0 and $\ln 2 / \ln 3$, there is a dense set of translation parameters for which the intersections have that particular Hausdorff dimension.

1. Dynamical systems and intersecting Cantor sets

Our motivation to study the intersection of Cantor sets comes from the discipline of Dynamical Systems. In the late 1800's, Poincaré identified a problem common to many nonlinear dynamical systems - how to describe the changes in a dynamical system when a homoclinic bifurcation takes place. This problem is still the center of much work in the theory of dynamical systems (see the recent monograph [9], for example). As a homoclinic bifurcation takes place, the behavior of a deterministic dynamical system can change from being very robust and predictable (with respect to initial conditions) to being completely chaotic.

Over the past 15 years, work has accelerated in the area of homoclinic bifurcations. Several major theories have been explored in conjunction with the creation and destruction of homoclinic bifurcations. Along with the possibility of strange attractors, some of the phenomena

associated with homoclinic bifurcations include omega explosions [8], infinitely many coexisting sinks [7], [10], [1] and antimonotonicity [4]. At this time, there is no single theory which integrates and predicts the order of occurrence of these phenomena. However, the development of the theories related to each of these phenomena requires the understanding of how certain stable and unstable manifolds intersect as the homoclinic bifurcation takes place. It is known that the intersections of stable and unstable manifolds have the shape of intersecting Cantor sets; because of this fact, it seems that in order to create a theory unifying omega explosions, infinitely many coexisting sinks and antimonotonicity, it is necessary to understand how Cantor sets intersect in general.

The theories of infinitely many sinks and antimonotonicity rely heavily on knowing when stable and unstable manifolds cannot be separated as they slide across one another, while the theory of omega explosions requires that the stable and unstable manifolds seldom intersect as they slide across one another. Each of these theories hold for parameter values close to a given homoclinic bifurcation in a dissipative planar diffeomorphism.

The criterion used for showing that the stable and unstable manifolds cannot be separated is that the product of the thicknesses of the manifolds is greater than one. Newhouse [6] defines the concept of thickness and show that two Cantor sets which have the product of their thicknesses greater than one cannot be separated. A Cantor set C in the line is represented as the difference of an interval C_0 and an infinite collection $\{U_j\}$ of disjoint open subintervals (also known as gaps) contained in C_0 .

More precisely, $C = \bigcap_{i=0}^{\infty} C_i$, where C_0 is the smallest interval containing C , and $C_i = C_0 - \bigcup_{j=0}^{i-1} U_j$. Such a sequence of sets $\{C_i\}$ is called a *defining sequence* of C . Let I_{ij} for $j = 1, 2$ be the two components of C_i on either side of the gap U_i and let $l(J)$ be the length of an interval J . The *thickness of a defining sequence* is defined by:

$$\tau(\{C_i\}) = \inf\{l(I_{ij})/l(U_i) : i \geq 1, \text{ where } j = 1, 2\}.$$

The *thickness of a Cantor set* is then defined by $\tau(C) = \sup\{\tau(\{C_i\}) : \{C_i\} \text{ is a defining sequence for } C\}$. Using this definition, Newhouse proved the following striking lemma:

Lemma. *Let C^1 and C^2 be two Cantor sets in R such that $\tau(C^1)\tau(C^2) > 1$. If C^1 is not contained in a gap of C^2 and C^2 is not contained in a gap of C^1 , then $C^1 \cap C^2 \neq \emptyset$.*

On the other hand, the theory of omega explosions uses the criterion that the sum of the limit capacities of the stable and unstable manifolds is less than one. The limit capacity, $d(C)$, of a Cantor set C will be defined as:

$$\limsup_{\epsilon \rightarrow 0} (\ln n(C, \epsilon) / \ln(1/\epsilon)),$$

where $n(C, \epsilon)$ is the minimum number of open intervals of radius ϵ needed to cover C . The limit capacity of a Cantor set is closely related to its Hausdorff dimension (see [6]).

Williams [11], Kraft [5] and Hunt, Kan, and Yorke [3] have explored the size of the intersections resulting from two Cantor sets being translated across one another. All of these explorations have assumed that the Cantor sets in question have product of thickness greater than one. Williams produced examples to show that the intersection of two Cantor sets can vary from being one point to containing another Cantor set. Independently, Kraft and Hunt et. al. further developed these ideas and determined all pairs of thicknesses for which the intersection may be a single point and all pairs of thicknesses which must contain another Cantor set. They also consider the problem of how often —as one Cantor set is being translated over another one— does the intersection contain another Cantor set.

In this paper it is our goal to completely describe how the intersection of two middle third Cantor sets change as they are translated across each other. Recall the standard construction for the middle third Cantor set. First we let C_0 be the closed interval I of length 1. Although we identify I with $[0, 1]$, we note that this construction can be carried out in any closed interval of length 1 (or any closed interval in general).

$$C_0 : \overline{\hspace{15em}} \\ \text{\scriptsize 0 \hspace{5em} 1}$$

Now remove from C_0 the open middle third interval, $(1/3, 2/3)$, to obtain $C_1 = [0, 1/3] \cup [2/3, 1]$:

$$C_1 : \overline{\hspace{5em}} \quad \overline{\hspace{5em}} \\ \text{\scriptsize 0 \hspace{2.5em} 1/3 \hspace{2.5em} 2/3 \hspace{2.5em} 1}$$

Next remove from each closed interval in C_1 the open middle third interval to obtain $C_2 = [0, 1/9] \cup [2/9, 3/9] \cup [6/9, 7/9] \cup [8/9, 1]$:

$$C_2 : \overline{\hspace{1em}} \quad \overline{\hspace{1em}} \quad \overline{\hspace{1em}} \quad \overline{\hspace{1em}} \\ \text{\scriptsize 0 \hspace{1em} 1/9 \hspace{1em} 2/9 \hspace{1em} 3/9 \hspace{1em} 6/9 \hspace{1em} 6/9 \hspace{1em} 8/9 \hspace{1em} 1}$$

This process is continued indefinitely creating a nested collection of closed nonempty sets $C_0 \supset C_1 \supset C_2 \supset C_3 \supset \dots$, where each C_n is

the union of 2^n intervals, each of length $1/3^n$. We define the middle third Cantor set to be the infinite intersection:

$$C = \bigcap_{n=0}^{\infty} C_n.$$

Suppose that two middle third Cantor sets are initially positioned on top of each other as in the following figure:

Now translate one Cantor set to the right x units ($x \in [0, 1]$) while keeping the other Cantor set in its initial position:

$$x + C : \left| \leftarrow x \rightarrow \right| \text{---} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---}$$

$$C : \frac{\text{---}}{0} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---} \quad \text{---} \text{---} \quad \frac{\text{---}}{1}$$

Hence, our goal is to analyze the intersections $(x + C) \cap C$. At first we will consider the problem of how often $x + C$ and C have a nonempty intersection. It can be shown that the thickness of a middle third Cantor set is exactly one, thus Newhouse's lemma (mentioned above) does not apply directly to intersecting middle third Cantor sets. However, by making small modifications to Newhouse's lemma, it can be shown [2] that in the middle third Cantor set context, $(x + C) \cap C \neq \emptyset$ for all $x \in [0, 1]$. In this paper we will present an elementary argument, which is independent of Newhouse's, to explicitly show that $(x + C) \cap C \neq \emptyset$ for all $x \in [0, 1]$. Our argument, also provides information which allows us to then determine the structure and the size of the intersections of two middle third Cantor sets. In fact, we will completely describe the intersections both in terms of their cardinality and in terms of their Hausdorff dimension. The rest of this paper is organized as follows. Explicit statements of our results are presented in section 2. Section 3 contains proof of the cardinality results and Section 4 contains proofs of the Hausdorff dimension results.

2. Notation and statement of main results

The points in the middle third Cantor set C can be conveniently represented by ternary decimals. Recall that for any $x \in [0, 1]$ we can express

x in a ternary decimal expansion:

$$(2.1) \quad x = (a_i) = \sum_{n=0}^{\infty} \frac{a_n}{3^n} = a_0 \cdot a_1 a_2 a_3 \dots$$

where $a_0 = 0$, $a_i = 0, 1$, or 2 for all $i > 0$.

For each nonzero x , representation (2.1) is unique except when $x = k/3^n$ and k and n are integers. In these exceptional cases x has two representations:

$$(2.2) \quad x = (a_i) = 0 \cdot a_1 a_2 \dots a_n 000 \dots (a_n \neq 0)$$

and

$$(2.3) \quad x = (a_i) = 0 \cdot a_1 a_2 \dots a_{n-1} (a_n - 1) 222 \dots (a_n \neq 0).$$

In order for there to be a 1 – 1 correspondence between the x 's in the interval $[0, 1]$ and their ternary representations (a_i) , we will use representation (2.3) if and only if $a_n = 1$.

The points in the middle third Cantor set C are characterized by the set of ternary representations which contain no 1's as digits. That is, $x \in C$ if and only if each a_i in the representation of x is either a 0 or 2. If there is an index n such that $a_n = 1$, $a_i = 0$ or 2 for $i < n$ and $a_i = 0$ (or $a_i = 2$) for all $i > n$, then we will still consider it is a point in C , since obviously a_n and a_i , $i > n$, can be rewritten as either 0 or 2.

To simplify our notation we will make the following definitions. The segment of digits $a_r a_{r+1} \dots a_{r+k}$, where a_r and $a_{r+k} = 1$, and for all $i = r + 1, \dots, r + k - 1$, $a_i = 0$ or 2 is called a *(1, 1)-string of x* . Furthermore, the *(1, 1)-string sequence of x* is defined to be the sequence of all mutually disjoint *(1, 1)-strings of x* starting with the first 1 digit of the ternary representation (a_i) . If there are an odd number of 1's in the ternary representation of x , then we will make the assumption that there is a 1 at the infinity of the ternary representation to form a final *(1, 1)-string of x* .

For each $x \in [0, 1]$ we will let $T = T(x)$ denote the number of 2's in the *(1, 1)-string sequence of x* . Similarly we will let $Z = Z(x)$ denote the number of 0's (a_0 does not count) in the complement of the *(1, 1)-string sequence of x* .

Finally, for each $x \in [0, 1]$, we will define the set C_x to be:

$$C_x = \{y \in C | x + y \in C\}.$$

Notice that the collection of points in the set C_x corresponds exactly to the points in $(x + C) \cap C$. Hence all results stated in terms of C_x apply directly to the intersection $(x + C) \cap C$. The phrase C_x contains a Cantor set is to mean that $C_x = C$ or that C_x contains a self similar copy of C . Since for $x = 0$ and for $x = 1$, the structure of $(x + C) \cap C$ is clear, to avoid triviality, we always assume that $x \in (0, 1)$ for discussion.

Result A: The cardinality of middle third Cantor set intersections.

1. Let $x \in (0, 1)$ have the expansion $x = 0 \cdot a_1 a_2 a_3 \dots$, then C_x contains a Cantor set if and only if either the number of 1's in the expansion is even and all but finitely many of the remaining digits are 0's, or the number of 1's is odd and all but finitely many of the remaining digits are 2's. All the x 's which satisfy these conditions form a countable, dense subset of $(0, 1)$.
2. The number of elements in C_x , denoted by $|C_x|$, satisfies:
 - i) $|C_x| = 3 \cdot 2^{T+Z-1}$ if and only if the number of 1's in the ternary representation of x is finite and $T + Z < \infty$. All the x 's which satisfy these conditions form a countable, dense subset of $(0, 1)$.
 - ii) $|C_x| = 2^{T+Z}$ if and only if the number of 1's in the ternary representation of x is infinite and $T + Z < \infty$. All the x 's which satisfy these conditions form an uncountable, dense subset of $(0, 1)$ having Lebesgue measure zero.
 - iii) $|C_x|$ is uncountably infinite in all other cases. All x 's, with the exception of an uncountable dense subset of $(0, 1)$ having Lebesgue measure zero, satisfy these conditions.

Result B: The Hausdorff dimension of middle third Cantor set intersections.

1. For every $0 \leq \alpha \leq 1$ there exists an $x \in (0, 1)$ such that the Hausdorff dimension of $(x + C) \cap C$ satisfies:

$$\dim[(x + C) \cap C] = (1 - \alpha) \frac{\ln 2}{\ln 3}.$$

2. Let D_α be the set of translation parameter x 's where all of the Hausdorff dimensions, $\dim[(x + C) \cap C]$, have the following common value:

$$D_\alpha = \left\{ x \in [0, 1] : \dim[(x + C) \cap C] = (1 - \alpha) \frac{\ln 2}{\ln 3} \right\}.$$

Then for every $0 \leq \alpha \leq 1$ we have that:

- i) D_α is a dense subset of $(0, 1)$.
- ii) Either $mD_\alpha = 0$ or $mD_\alpha = 1$, where mD_α is the Lebesgue measure of D_α .

3. Proof of Result A: The cardinality of the intersection

Throughout the paper, x will represent an arbitrary number in the interval $(0, 1)$. We will identify x with its ternary representation (a_i) where each a_i is a 0, 1, or 2 digit for all positive integers i . Similarly, y will be any number in the interval $[0, 1]$ which is also a point of the middle third Cantor set C . We will identify y with its ternary representation (b_i) where each b_i is a 0 or 2 digit for each positive integer i . We define the indices I_k for each positive integer k by:

$$I_k = \max\{i | 0 \leq i < k, \text{ and } a_i + b_i = 0 \text{ or } 3\}, \quad k = 1, 2, 3, \dots$$

Notice that I_k always exists due to the fact that $a_0 + b_0 = 0 + 0 = 0$. The translate of y in C by a distance of x will be given by $t = x + y$. We will identify t with its ternary representation (d_i) . Our initial goal is to understand when t is a point of the middle third Cantor set C and when it is not. In the following series of lemmas we will present four conditions which guarantee that a translated of a point from C does not fall on another point of C ; that is, conditions which imply that $t = x + y$ is not an element of C .

Lemma 3.1. *If $a_k + b_k = 4$ for some $k \geq 1$, $a_i \neq 1$ for all $I_k < i < k$, and $a_j + b_j \neq 4$ for some $j > I_k$, then $t = (d_i) \notin C$.*

Proof: By the definition of I_k we see that our assumption of $a_i \neq 1$ for all $I_k < i < k$ implies that $a_i + b_i = 2$ or 4 for all $I_k < i < k$. Further, our assumption that $a_k + b_k = 4$ implies that $d_i = a_i + b_i + 1 \pmod{3}$ for all $I_k < i < k$. Hence, we may conclude that $d_{I_k} = 1$. We also have that $d_k = 1$ or 2 since $a_k + b_k = 4$. If we can show that $d_i < 2$ for some $i > I_k$, then $(d_i) \notin C$. The index $j > I_k$ for which $a_j + b_j \neq 4$ can be divided into two cases:

Case 1: $j < k$. As before, we have $a_j + b_j = 2$, hence $d_j = 0$.

Case 2: $j > k$. Without loss of generality, assume that j is the smallest such index greater than k . If $a_j + b_j = 3$, then $d_j = 0$ or 1 . If $a_j + b_j < 2$, then $d_{j-1} = a_{j-1} + b_{j-1} \pmod{3} = 4 \pmod{3} = 1$. Suppose that $a_j + b_j = 2$. Then $d_{j-1} = 1$ if $d_j = 2$. Otherwise, $d_j = a_j + b_j + 1 \pmod{3} = 0$. In either case we have $t = (d_i) \notin C$. ■

Lemma 3.2. *If $a_k + b_k = 3$ for some $k \geq 1$, $a_i \neq 1$ for all $I_k < i < k$, and $a_j + b_j > 0$ for some $j > k$, then $t = (d_i) \notin C$.*

Proof: Repeating the first part of the proof of lemma 3.1 (with $a_k + b_k = 3$ replacing $a_k + b_k = 4$), we can again conclude that $d_{I_k} = 1$. Here the hypothesis that $a_k + b_k = 3$ implies that $d_k = 0$ or 1 . Without loss of generality, let $j > k$ be the smallest index such that $a_j + b_j > 0$. If $d_j > 0$, then clearly $(d_i) \notin C$. If $d_j = 0$, since $a_j + b_j > 0$, so $d_{j-1} = a_{j-1} + b_{j-1} + 1 \pmod{3} = 0 + 1 = 1$. Hence $t = (d_i) \notin C$. ■

Lemma 3.3. *If $a_j + b_j = a_k + b_k = 1$ for some $j < k$, $a_i \neq 1$ for all $j < i < k$, and $a_l + b_l \neq 4$ for some $l > k$, then $t = (d_i) \notin C$.*

Proof: First we will consider the case in which $a_i + b_i \leq 2$ for all $j < i < k$. It follows that $d_j = 1$. Without loss of generality, assume that $l > k$ is the smallest index such that $a_l + b_l \neq 4$. Notice that $d_k = 1$ or 2 . By considering the cases of $a_l + b_l$ equals 3 or 2 , or less than 2 , as discussed in the proof of lemma 3.1, it will imply that $d_l = 0, 1$ or $d_{l-1} = 1$. So $t = (d_i) \notin C$.

Now suppose that $a_i + b_i \geq 3$ for some $j < i < k$. We define i_0 to be the maximum index between j and k such that $a_i + b_i \geq 3$. Due to the fact that $a_{i_0} \neq 1$, we see that $a_{i_0} + b_{i_0} = 4$ which in turn implies that $d_{i_0} = 1$. Now, $a_i + b_i \leq 2$ for all $i_0 < i < k$. At this point we appeal to the first part of this lemma's proof to conclude that $t = (d_i) \notin C$. ■

Lemma 3.4. *If $a_j + b_j = 1$, $a_k + b_k = 0$ for some $k > j$, $a_i \neq 1$, for $j < i < k$, and $a_l + b_l > 0$ for some $l > k$ (or if $a_{k-1} + b_{k-1} = 2$), then $t = (d_i) \notin C$.*

Proof: Assume at first that $a_i + b_i \leq 2$ for all $j < i < k$. This assumption implies that $d_j = 1$. Note that $d_k = 0$ or 1 . Thus if $a_{k-1} + b_{k-1} = 2$, then $d_{k-1} = 2$, hence $(d_i) \notin C$. If $a_l + b_l > 0$ for some $l > k$, without loss of generality, assume that l is the smallest one of such index. If $d_l > 0$, then $(d_i) \notin C$. If $d_l = 0$, as in the proof of lemma 3.2, we have $d_{l-1} = 1$, so $(d_i) \notin C$.

Now suppose that $a_i + b_i \geq 3$ for some $j < i < k$. Define i_0 to be the largest index i between j and k such that $a_i + b_i \geq 3$, then $d_{i_0} = 1$ (as in the proof of lemma 3.3). Note that $a_i + b_i \leq 2$ for all $i_0 < i < k$, implying $t = (d_i) \notin C$. ■

Proposition 3.5. *Let x be any real number in the interval $(0, 1)$ with an even number of 1 's in its ternary representation (including no 1 's at all in which case $x \in C$). If $Z < \infty$, then $|C_x| = 3 \cdot 2^{T+Z-1}$.*

Proof: Let $x = (a_i)$ and let $a_i = 1$ for $i = p_1, q_1, \dots, p_n, q_n$, where $p_1 < q_1 < \dots < p_n < q_n$. Assume that $a_i = 0$ or 2 for all $i > q_n$ and $i < p_1$. By conventions (2.2) and (2.3), there is an $i > q_n$ such that $a_i = 0$, so $Z > 0$. Now let i_Z be the largest index such that $a_{i_Z} = 0$. Clearly, $q_n < i_Z < \infty$ since $Z < \infty$, and $a_i = 2$ for all $i > i_Z$.

We will first show that a necessary condition for $x + y \in C$, where $y = (b_i)$ and each b_i is a 0 or 2 is that

$$(3.1) \quad b_{p_i} = 0 \text{ and } b_{q_i} = 2 \text{ for } i = 1, \dots, n.$$

To see that $b_{p_1} = 0$ we notice that if $b_{p_1} \neq 0$, then $a_{p_1} + b_{p_1} = 3$; and then by lemma 3.2, we would have that $x + y = (d_i) \notin C$. To see that $b_{q_1} = 2$ we notice that if $b_{q_1} \neq 2$, then $b_{q_1} = 0$, $a_{p_1} + b_{p_1} = a_{q_1} + b_{q_1} = 1$ and $a_{i_Z} + b_{i_Z} \neq 4$; so by lemma 3.3, we would have that $(d_i) \notin C$. Hence $b_{p_1} = 0$ and $b_{q_1} = 2$.

Now suppose that (3.1) is true for $i \leq k-1$. We first show that $b_{p_k} = 0$. If $b_{p_k} \neq 0$, then $a_{p_k} + b_{p_k} = 3$. Since $a_{q_{k-1}} + b_{q_{k-1}} = 3$, so $I_{p_k} \geq q_{k-1}$ and $a_i \neq 1$ for all $I_{p_k} < i < p_k$. By lemma 3.2, we have $(d_i) \notin C$. So $b_{p_k} = 0$. Next, we show that $b_{q_k} = 2$. Suppose not, then $b_{q_k} = 0$ and $a_{q_k} + b_{q_k} = 1$. Recall that $a_{p_k} + b_{p_k} = 1$ and that $a_{i_Z} + b_{i_Z} = b_{i_Z} \neq 4$, where $i_Z > q_k$. Applying lemma 3.3 we see that $(d_i) \notin C$. The contradiction shows that $b_{q_k} = 2$. So (3.1) is true by induction.

Via the following three claims we will examine the remaining choices for the b_i 's such that $x + y = (d_i) \in C$:

Claim 1. Suppose that i is an index such that $0 < i < i_Z$ and a_i is in the complement of the (1,1)-string sequece of x . If $a_i = 0$, then b_i can be either a 0 or 2. If $a_i = 2$, then $b_i = 0$.

Claim 2. Suppose that i is an index such that $p_j < i < q_j$, where $j = 1, \dots, n$. If $a_i = 0$, then $b_i = 2$. If $a_i = 2$, then b_i can be either a 0 or 2.

Claim 3. There are exactly three permissible choices for the sequence of b_i 's for $i \geq i_Z$.

For index i in Claim 1, we have that $a_i \neq 1$ therefore $a_i + b_i = 0, 2$ or 4 . Since $a_l + b_l = 3$ for $l = q_j, j = 1, \dots, n$, we have

$$I_i \geq \begin{cases} 0 & \text{if } 0 < i < p_1 \\ q_j & \text{if } q_j < i < p_{j+1}, \quad j = 1, \dots, n-1 \\ q_n & \text{if } q_n < i < i_Z. \end{cases}$$

Thus $a_j \neq 1$ for all $I_i < j < i$. Since $a_{i_Z} + b_{i_Z} \leq 2$, lemma 3.1 implies that $a_i + b_i \neq 4$, and thus, $a_i + b_i = 0$ or 2 . Note that $a_{i_Z} = 0$, so there are $Z - 1$ zeros which precede a_{i_Z} left in the complement of x 's $(1, 1)$ -string sequence.

In Claim 2, it follows from lemma 3.4 that for all i such that $p_j < i < q_j$, $j = 1, \dots, n$, we must have that $a_i + b_i \neq 0$ and hence $a_i + b_i = 2$ or 4 . Note that $a_{q_j} + b_{q_j} = 3$, thus during the addition of x and y there will be a 1 digit to be carried forward through all indices i where $p_j < i \leq q_j$ which will make $d_i = 0$ or 2 . Therefore $b_i = 2$ if $a_i = 0$ and b_i can be either a 0 or 2 if $a_i = 2$.

In Claim 3 we first show that either $b_i = 2$ for all $i > i_Z$ or $b_i = 0$ for all $i > i_Z$. Suppose the contrary; without loss of generality we will assume that $b_r = 0$ and $b_{r+1} = 2$ for some $r > i_Z$. (The situation where $b_r = 2$ and $b_{r+1} = 0$ for some $r > i_Z$ is handled similarly.) We then have that $a_{r+1} + b_{r+1} = 4$ and $a_r + b_r = 2 \neq 4$. Notice that $a_{q_n} + b_{q_n} = 3$ thus $q_n \leq I_{r+1} < r$. Also notice that $a_i \neq 1$ for all $I_{r+1} < i < r + 1$. Now lemma 3.1 implies that $(d_i) \notin C$.

To complete the verification of Claim 3 we see that if $b_i = 2$ for all $i > i_Z$, then b_{i_Z} must be 0; otherwise $a_{i_Z} + b_{i_Z} = 2 \neq 4$ and $a_k + b_k = 4$ for any $k > i_Z$. Therefore $q_n \leq I_k < i_Z$ and $a_i \neq 1$ for all $I_k < i < k$. Applying lemma 3.1 will now cause a contradiction. If $b_i = 0$ for all $i > i_Z$, then $d_i = 2$ for all $i > i_Z$ and $d_{i_Z} = a_{i_Z} + b_{i_Z} = 0 + b_{i_Z} = b_{i_Z}$; thus, b_{i_Z} can be 0 or 2. It follows that we can have exactly three possibilities for the choices of the sequence of b_i 's for $i \geq i_Z$.

The results from Claims 1–3 together with the multiplication principle now imply that the total number of choices for the b_i such that $t = x + y \in C$ is given by $3 \cdot 2^{T+Z-1}$. If there are no 1's at all in x 's ternary representation, then $T = 0$. Since $0 < x < 1$, there must be at least one zero in the representation, so $Z > 0$. By applying the above argument it is easy to verify that the counting formula for $|C_x|$ will still be valid. ■

An immediate consequence from the proof of Proposition 3.5 is:

Corollary 3.6. *Let x be any real number of the interval $(0, 1)$ with an even number of 1's in its ternary representation. If $Z = Z(x) = \infty$, then $|C_x|$ is uncountably infinite. Furthermore, if all but finitely many digits of the ternary representation of x are 0's, then C_x contains a Cantor set.*

Proposition 3.7. *Let x be any real number in the interval $(0, 1)$. Assume that the number of 1's in the ternary representation of x is odd (in which case the final $(1, 1)$ -string of x will contain all but finitely many digits). If $T < \infty$, then $|C_x| = 3 \cdot 2^{T+Z-1}$.*

Proof: For simplicity we will assume that the number of 1's in the ternary representation of x is 3; the general case can be proved similarly as in proposition 3.5. Suppose that $a_p = a_q = a_r = 1$, where $p < q < r$. Let i_T be the largest index for which $a_{i_T} = 2$. Clearly i_T exists by conventions (2.2) and (2.3); furthermore, $i_T > r$, hence $T > 0$.

As shown in the proof of proposition 3.5, a necessary condition for $x + y = (d_i) \in C$ is that $b_p = 0$, $b_q = 2$ and $b_r = 0$.

Via the following three claims we will examine the remaining choices for the b_i 's such that $x + y = (d_i) \in C$:

Claim 1. Suppose that i is an index such that $0 < i < p$ or $q < i < r$. If $a_i = 0$, then b_i can be either a 0 or 2. If $a_i = 2$, then $b_i = 0$.

Claim 2. Suppose that i is an index such that $p < i < q$ or $r < i < i_T$. If $a_i = 0$, then $b_i = 2$. If $a_i = 2$, then b_i can be a 0 or 2.

Claim 3. There are exactly three permissible choices for the sequence of b_i 's for $i \geq i_T$.

The verification for Claim 1 is the same as the verification for Claim 1 in the proof of proposition 3.5. Similarly, the verification for the portion of Claim 2 in which $p < i < q$ is the same as the verification for Claim 2 in the proof of proposition 3.5.

To complete the verification of Claim 2 for which $r < i < i_T$, we first notice that $a_r + b_r = 1$ and $a_i = 0$ for all $i > i_T$, thus $b_i = 0$ for all $i > i_T$ or $b_i = 2$ for all $i > i_T$, otherwise lemma 3.4 implies that $x + y \notin C$. We will assume, without loss of generality, that $b_i = 0$ for all $i > i_T$. Thus $d_i = 0$ for all $i > i_T$. Also $a_r + b_r = 1$ implies that $a_i + b_i \neq 0$ for all $r < i < i_T$. Otherwise, since $a_{i_T} + b_{i_T} > 0$, lemma 3.4 will imply that $(d_i) \notin C$. So $a_i + b_i = 2$ or 4 for $r < i < i_T$. Because $a_{i_T+1} + b_{i_T+1} = 0$, by lemma 3.4 $a_{i_T} + b_{i_T} \neq 2$. Hence $b_{i_T} = 2$ and $d_{i_T} = 1$. During the addition of x and y there will be a 1 digit which is carried forward for all $r < i \leq i_T$ due to the fact that $a_i + b_i$ is a 2 or 4 for all $r < i < i_T$. Hence we conclude that $d_i = 0$ or 2 for $r \leq i < i_T$.

In Claim 3 we observe that, as above, either $b_i = 2$ for all $i > i_T$ or $b_i = 0$ for all $i > i_T$. If $b_i = 0$ for all $i > i_T$, as argued above, b_{i_T} must be 2. If $b_i = 2$ for all $i > i_T$, then it is easy to see that b_{i_T} will be a 2 or 0. If $b_{i_T} = 2$, then $d_{i_T} = 1$, $d_i = 0$ or 2 for $r \leq i < i_T$ and $d_i = 2$ for all $i > i_T$. If $b_{i_T} = 0$, then we have that either $d_r = 1$ and $d_i = 2$ for all $i > r$, or $d_r = 2$ and $d_{i_0} = 1$ for some $r < i_0 < i_T$ and $d_i = 2$ for all $i > i_0$.

The results from Claims 1–3 together with the multiplication principle imply that $|C_x| = 3 \cdot 2^{T+Z-1}$ as desired. ■

An immediate consequence of the proof of proposition 3.7 is:

Corollary 3.8. *Let x be any real number in the interval $(0, 1)$. Assume that the number of 1's in the ternary representation of x is odd. If T is infinite, then $|C_x|$ is uncountably infinite. In addition, if all but finitely many digits of x are 2's, then C_x contains a Cantor set.*

Proposition 3.9. *Let x be any real number in the interval $(0, 1)$. Assume that the number of 1's in the ternary representation of x is infinite. Also assume that both $Z < \infty$ and $T < \infty$. Then $|C_x| = 2^{T+Z}$ and such x form an uncountable dense subset of $(0, 1)$ with Lebesgue measure zero.*

Proof: Let $a_{i_j} = 1$ for $j = 1, 2, 3, \dots$ be the infinitely many 1's in the ternary representation of x . Let $y = (b_i)$ satisfy $x + y \in C_x$. As discussed in the proof of proposition 3.5,

$$b_{i_j} = \begin{cases} 0 & \text{if } i \text{ is odd} \\ 2 & \text{if } i \text{ is even.} \end{cases}$$

Since T and Z are finite, there exists an index k such that $a_i = 0$ for all a_i inside of the $(1, 1)$ -strings of x given by $a_{i_j} a_{i_j+1} \dots a_{i_{j+1}}$ for all $j \geq k$. By the same reason as for claim 2 of proposition 3.5, b_i must be 2 for all such i . Furthermore, $a_i = 2$ for all the a_i between the above $(1, 1)$ -strings of x . Hence $b_i = 0$ for all such i , as in claim 1 of proposition 3.5. So there is exactly one choice for each b_i for all $i \geq i_k$. Also, we can see that such (a_i) are uncountably many but have Lebesgue measure zero.

We now consider the b_i 's where $i < i_k$. Here we can reduce our proof to the situation where the number of 1's in the ternary representation of x is even. Using the same argument as we did in the proof of proposition 3.5, we see that the number of choices for the b_i 's where $i < i_k$ is given by 2^{T+Z} . Therefore $|C_x| = 2^{T+Z}$. ■

An immediate consequence of the proof of proposition 3.9 is:

Corollary 3.10. *Let x be any real number in the interval $(0, 1)$. Assume that the number of 1's in the ternary representation of x is infinite. If either Z or T is infinite, then $|C_x|$ is uncountably infinite.*

Proposition 3.11. *Let x be any real number in the interval $(0, 1)$, then C_x contains a Cantor set if and only if either the number of 1's in*

(a_i) is even and all but finitely many of the a_i 's are zeros, or the number of 1's in (a_i) is odd and all but finitely many of the a_i 's are 2's.

Proof: We only need to prove that the above conditions are necessary as corollaries 3.6 and 3.8 have shown that the conditions are sufficient. Let $x + y = (d_i) \in C_x$, then C_x contains a Cantor set if and only if each d_i can be arbitrarily chosen to be a 0 or 2 starting at some index i . We will complete the proof via a contrapositive argument. If x satisfies any one of the following cases, then C_x does not contain a Cantor set:

Case 1: The number of 1's is even and $a_i = 2$ for infinitely many i .

Case 2: The number of 1's is odd and $a_i = 0$ for infinitely many i .

Case 3: The number of 1's is infinite.

In Case 1, first suppose that $a_i = 2$ for all $i \geq k$ for some fixed index k . If there is a $j > k$ such that $b_j = 2$ and $b_{j+1} = 0$, then $a_j + b_j = 4$ and $a_{j+1} + b_{j+1} \neq 4$. By lemma 3.1, $(d_i) \notin C$. So either $b_i = 0$ for all $i \geq k_1$ or $b_i = 2$ for all $i \geq k_1$ for some index k_1 . Next, if infinitely many 0's and infinitely many 2's follow the (1,1)-string sequence of x , then lemma 3.1 implies that for these i 's, b_i must be 0 whenever $a_i = 2$; therefore, $d_i = 2$ and will never be 0. Thus, C_x cannot contain a Cantor set for those x in Case 1. Case 2 is handled in the same manner.

In Case 3, let $a_{i_j} = 1$ for $j = 1, 2, 3, \dots$ be the infinitely many 1's in (a_i) . As in the proof of proposition 3.9 we have that

$$b_{i_j} = \begin{cases} 0 & \text{if } j \text{ is odd} \\ 2 & \text{if } j \text{ is even.} \end{cases}$$

It follows that d_{i_j} must be 0 if j is even, and therefore, $t = (d_i) \notin C$. ■

Finally, by combining the results of proposition 3.5 through proposition 3.11 we now have a proof of Result A on the cardinality of middle third Cantor set intersections.

4. Proof of Result B: The Hausdorff dimension of the intersection

Let $n_1 < n_2 < \dots < n_i < \dots$ be any subsequence of the set of positive integers. For each positive integer k , we define the index k' to be $k' = \max\{i | n_i \leq k\}$, and set:

$$(4.1) \quad \alpha = \alpha(n_1, n_2, \dots) = \limsup_{k \rightarrow \infty} \frac{k'}{k}.$$

Notice that each α satisfies $0 \leq \alpha \leq 1$. For each sequence n_1, n_2, \dots and the corresponding α , a subset C^α of the middle third Cantor set C will

be formed as follows. C^α is made up of all the x 's from C which have digits a_i preassigned if the index i is from the sequence n_1, n_2, \dots ; the remaining digits in the ternary representations are arbitrary:

$$\begin{aligned} C^\alpha &= C^\alpha(a_{n_1}, a_{n_2}, \dots) \\ &= \{x \in C \mid a_{n_i} \text{ is preassigned a 0 or 2 for all } i\}. \end{aligned}$$

Let $\dim C^\alpha$ denote the Hausdorff dimension of C^α .

Proposition 4.1. $\dim C^\alpha = (1 - \alpha) \frac{\ln 2}{\ln 3}$.

Proof: Without loss of generality we can assume that $a_{n_i} = 0$ for all $i \geq 1$. C^α can be constructed by first setting E_0 to be the interval $[0, 1]$. Next we define E_1 to be the set given by:

$$E_1 = \begin{cases} [0, 1/3] & \text{if } n_1 = 1 \\ [0, 1/3] \cup [2/3, 1] & \text{otherwise.} \end{cases}$$

Sets E_n for $n > 1$ will be defined inductively. Suppose that E_k is the union of $2^{k-k'}$ basic ternary intervals of length $(1/3)^k$. E_{k+1} is defined by:

$$E_{k+1} = \begin{cases} \bigcup_{[a,b] \subset E_k} [a, a + (1/3)^{k+1}] & \text{if } n_i = k+1 \text{ for some } i \\ \bigcup_{[a,b] \subset E_k} [a, a + (1/3)^{k+1}] \cup [b - (1/3)^{k+1}, b] & \text{otherwise.} \end{cases}$$

Finally we have that $C^\alpha = \bigcap_{n=0}^{\infty} E_n$.

We will define a probability measure P on C^α by:

$$P(C_\alpha \cap I_k) = (1/2)^{k-k'}, \quad k = 1, 2, \dots$$

where I_k is any basic ternary interval of E_k .

It is straightforward to verify that P is a well-defined measure. In addition, for each real number $s > 0$, we have that:

$$\frac{P(C_\alpha \cap I_k)}{(\text{diam } I_k)^s} = \frac{(\frac{1}{2})^{k-k'}}{(\frac{1}{3})^{ks}} = \frac{3^{(k'-k)\frac{\ln 2}{\ln 3}}}{3^{-ks}} = 3^{k(s - (1 - \frac{k'}{k})\frac{\ln 2}{\ln 3})}.$$

Next we define θ to be the nonnegative value given by:

$$\theta = \liminf_{k \rightarrow \infty} \left(1 - \frac{k'}{k}\right) \frac{\ln 2}{\ln 3} = (1 - \alpha) \frac{\ln 2}{\ln 3},$$

and observe that:

$$\limsup_{k \rightarrow \infty} \frac{P(C_\alpha \cap I_k)}{(\text{diam } I_k)^s} = \begin{cases} 0 & \text{if } s < \theta \\ \infty & \text{if } s > \theta. \end{cases}$$

It now follows that $\dim C^\alpha = (1 - \alpha) \frac{\ln 2}{\ln 3}$. ■

Using proposition 4.1, we will study the Hausdorff dimension of $(x + C) \cap C$ for any given $x \in [0, 1]$. Let x have the ternary representation (a_i) and let $a_{n_1} a_{n_2} \dots a_{n_i} \dots$ be the subsequence of (a_i) consisting of all the 0's inside the $(1, 1)$ -string sequence of x and all the 2's outside the string sequence together with all the 1's in the ternary representation of x . It follows from the proofs of propositions 3.5, 3.7 and 3.9 that $(x + C) \cap C$ consists of those $(d_i) \in C$ such that each d_{n_i} , where $i = 1, 2, \dots$, must be a fixed digit, while the rest of the digits in the representation (d_i) can be randomly chosen to be a 0 or 2. By proposition 4.1, we now have that:

$$\dim[(x + C) \cap C] = (1 - \alpha) \frac{\ln 2}{\ln 3},$$

where α is defined by equation (4.1). From the discussion we see that adding a finite number of $(1, 1)$ -strings to (or deleting from) the beginning of (a_i) is equivalent to adding (or deleting) a finite number of terms to the beginning of the subsequence $a_{n_1} a_{n_2} \dots a_{n_i} \dots$. As a result, the upper limit in (4.1) will be unchanged. We hence have the following corollary.

Corollary 4.2. *Let $x = (a_i)$ and $y = (b_i)$ be any two points in $(0, 1)$. If there exist integers m and n such that $a_i = b_{i+n}$ for all $i > m$ and both $a_1 \dots a_m$ and $b_1 \dots b_{m+n}$ have an even (or odd, respectively) number of 1's, then*

$$\dim[(y + C) \cap C] = \dim[(x + C) \cap C].$$

To continue, we define the set D_α to be the set of translation parameters x which correspond to intersections $(x + C) \cap C$ having a common value; more precisely,

$$D_\alpha = \left\{ x \in [0, 1] \mid \dim[(x + C) \cap C] = (1 - \alpha) \frac{\ln 2}{\ln 3} \right\}.$$

Proposition 4.3. *For every $0 \leq \alpha \leq 1$, D_α is a dense subset of $(0, 1)$.*

Proof: We will first show that $D_\alpha \neq \emptyset$. Let $0 \cdot \epsilon_1 \epsilon_2, \dots, \epsilon_i \in \{0, \dots, 9\}$, be the base 10 decimal expansion of α . Clearly $\lim_{n \rightarrow \infty} \frac{\epsilon_1 \dots \epsilon_n}{10^n} = \alpha$. Let

$x \in C$ be chosen so that in the first 10^n digits of its ternary representation there are exactly $\epsilon_1 \dots \epsilon_n$ digits which are 2's and the rest of the digits are 0's. From the proof of proposition 3.5 we know that the set $(x + C) \cap C$ consists precisely of those $(b_i) \in C$ such that $b_i = 0$ if $a_i = 2$ and $b_i = 0$ or 2 otherwise. It now follows from proposition 4.1 and the construction of x that $x \in D_\alpha$ and therefore $D_\alpha \neq \emptyset$. Furthermore, if y is obtained by adding a finite number of $(1, 1)$ -strings to the tail digits of x , then corollary 4.2 implies that $y \in D_\alpha$. Clearly these y 's form a dense subset of $(0, 1)$. ■

Proposition 4.4. *For every $0 \leq \alpha \leq 1$, either $mD_\alpha = 0$ or $mD_\alpha = 1$. Here mD_α is the Lebesgue measure of D_α .*

Proof: Let $\beta \in (0, 1)$; we will show that if $mD_\alpha > 0$ then $mD_\alpha > \beta$ and therefore $mD_\alpha = 1$. Notice that if $mD_\alpha > 0$, then there exists a ternary interval I of length 3^{-n} such that:

$$(4.2) \quad 1 \geq \frac{m(D_\alpha \cap I)}{m(I)} > \beta.$$

Proposition 4.4 will be proven if we can show that the interval I in expression (4.2) can be replaced by any ternary interval of length 3^{-n} from $[0, 1]$. Let J be an arbitrarily chosen ternary interval of length 3^{-n} from $[0, 1]$. Recall that all points in I (or J , respectively) have the same beginning n digits in their ternary expansion.

For any given pair of points $(a_i), (b_i)$ with $(a_i) \in I$ and $(b_i) \in J$, either (a_i) and (b_i) will both have an even (odd) number of 1's in their first n digits or one will have an even number of 1's and the other will have an odd number of 1's in their first n digits.

Suppose that both $a_1 \dots a_n$ and $b_1 \dots b_n$ have an even (or odd, respectively) number of 1's. Let A denote the translation of $I \cap D_\alpha$ to J ; that is,

$$A = \{y_x \in J | y_x = 0 \cdot b_1 \dots b_n a_{n+1} a_{n+2} \dots, \text{ for all } x = (a_i) \in (I \cap D_\alpha)\}.$$

The points x and y_x satisfy the hypotheses of corollary 4.2, thus $\dim[(y + C) \cap C] = \alpha$ for all $y \in A$. Therefore $A \subseteq (J \cap D_\alpha)$ and we now see that $m(I \cap D_\alpha) = m(A) \leq m(J \cap D_\alpha)$. Hence expression (4.2) remains true when I is replaced by J .

Now suppose that one of the sequences $a_1 \dots a_n$ or $b_1 \dots b_n$ has an odd number of 1's and the other sequence has an even number of 1's. Let B be the union of the similitudes of $I \cap D_\alpha$ on every middle third ternary

interval of $J \setminus C$; that is,

$$B = \{y_x \in J \mid y_x = 0 \cdot b_1 \dots b_{n+k} a_{n+1} a_{n+2}, \dots, \text{ for all } x = (a_i) \in (I \cap D_\alpha), \\ \text{where } b_{n+k} = 1, b_i = 0 \text{ or } 2 \text{ for } i = n+1, \dots, n+k-1, k = 1, 2, \dots\}.$$

It is straightforward to verify that $mB = m(I \cap D_\alpha)$. Now by corollary 4.2 we have $\dim[(y + C) \cap C] = \alpha$ for all $y \in B$. So $B \subseteq (J \cap D_\alpha)$ and expression (4.2) remains true when I is replaced by J . ■

By combining the results in this section we obtain a proof of Result B on the Hausdorff dimension of middle third Cantor set intersections.
