

Multiculturalisme. Una bibliografia

Des que hom començà a emprar el terme «multiculturalisme» en els anys seixanta fins a l'actualitat, aquest concepte ha anat rebent diferents matisos. Especialment en les primeres publicacions, trobem el concepte utilitzat senzillament com a sinònim de pluriculturalitat, però poc a poc es va anar imposant un deix més aviat normatiu que li ha anat restant el seu valor merament operatiu i analític. Per aquesta raó, i molt concretament també a causa de les diverses crítiques que ha rebut el concepte, són cada vegada més els antropòlegs que opten per prescindir del seu ús tot sentint-se més còmodes amb altres idees com per exemple la de la «interculturalitat». Tot això queda bastant ben reflectit en la bibliografia que presentem a continuació. Tal com és ben evident, la problemàtica del multiculturalisme es troba estretament relacionada amb qüestions com les de l'etnicitat o la immigració. Per aquesta raó, en la nostra bibliografia, apareixen ocasionalment alguns títols relacionats explícitament amb aquestes problemàtiques, però resulta clar que aquestes àrees d'investigació requereixen el seu propi tractament bibliogràfic, i que en l'elaboració del present llistat calia, no perdre de vista el seu primer objectiu: el «multiculturalisme», entès en el sentit més ampli del mot.

Tal com és habitual en els reculls bibliogràfics de la RIC, la llista feta per ordre alfabètic de les diverses publicacions és completada amb un índex analític. Per a l'elaboració d'aquest índex, a més de tenir en compte l'orientació temàtica de cada treball, ens hem servit també de criteris geogràfics, i, en ocasions, també de caire metodològic. El lector hi trobarà una gran quantitat de treballs que fan referència al Canadà, als EUA i a Austràlia cosa que no ens ha d'estrianyar atès que fou en aquests països, especialment en els dos primers, on la problemàtica del multiculturalisme començà a debatre's amb més intensitat i despertà un interès

més gran a causa de la particular composició social de les societats respectives. L'índex temàtic de la present bibliografia permet també que ens adonem de la forta incidència que han tingut els discursos sobre el multiculturalisme i la interculturalitat en un àmbit tan important com és el de l'educació. Atesa la controvertida natura del concepte de «multiculturalisme» m'ha semblat adient també assenyalar en l'índex analític, sempre que m'ha estat possible, aquelles publicacions amb aproximacions crítiques al tema (vegeu *Multiculturalisme. Crítica*), treballs que en la seva gran majoria han anat apareixent al llarg de la dècada dels noranta i que contrasten fortament amb les visions, en ocasions, un tant ingènues que es feien quan hom començà a tematitzar la problemàtica.
