1. Metodologia emprada per configurar la bibliografia.

Les principals eines de recerca emprades per configurar aquesta bibliografia han estat: el cercador del Consorci de Biblioteques Universitàries de Catalunya (www.cbcu.es), la sol·licitud de referències a llistes electròniques especialitzades, l'enllaçament de links, la revisió i consulta d'especialistes i, finalment s'han completat apartats amb el cercador Google (www.google.com). La metodologia emprada és, doncs, una expressió més de la "revolució" que està fent l'ús d'Internet en la recerca científica, i que alhora ens porta a nous dilemes. El principal problema per elaborar aquesta relació bibliogràfica ha estat la gestió i tria de la immensitat d'informació accessible.

2. Criteris en la selecció de la bibliografia

Hem intentat fer compatibles: els clàssics en antropologia política, una selecció que mostrés l'evolució seguida dins d'aquest camp d'estudi, les publicacions especialitzades i, per últim, una petita mostra de les aportacions més destacables que, amb un criteri més ampli i multidisciplinari, s'han publicat entorn de l'encontre entre antropologia i política al món d'avui. Ca' reconéixer que el resultat, però, pateix d'un baix que prioritza les publicacions en anglès i el camp d'estudi dels moviments socials.

3. Debats, països i temes dominants

L'antropologia política, com l'antropologia en general, més en uns països que en altres, ha deixat de banda la vessam exòtica, per passar a orientar-se cap a l'estudi de les societats del seu propi origen i presència. En aquest procés van aparèixer nous debats, com el de les relacions Nord-Sud o noves temàtiques d'especialització com els estudis de la Mediterrània.

En el moment actual ens trobem

davant una proliferació de publicacions que són un reflex de la revitalització del tema, especialment en països com els EUA, l'Estat espanyol, Itàlia, Equador o Mèxic.

Nous temes prenen protagonisme, com els estudis dels moviments socials, l'impacte de la globalització, canvis en les relacions socials i la dinàmica de xarxes, amb el predomini de l'enfocament global-local i en aquest context cudent es dóna el debat entre neomarxistes i postmodernistes.

Amb aquesta etapa l'antropologia política es difonina en un encontre entre disciplines, com succeeix amb la sociologia i la psicologia social, i la bibliografia compartida és una mostra més d'aquest encontre de disciplines al voltant de la política.
