

Antropologia del temps

El següent recull bibliogràfic està organitzat en sis grans blocs que agrupen les principals temàtiques conreades en allò que avui anomenem antropologia del temps. El primer apartat reuneix els estudis teòrics, que són els menys nombrosos a causa, precisament, de la relativa joventut d'aquest nou camp d'estudi de l'antropologia. El treball més important en aquest sentit és el d'Alfred Gell. El monogràfic publicat a la revista *Current Anthropology* l'any 2002 i el volum editat per James i Mills el 2005 són també molt remarcables, per això els hem inclòs en aquest primer apartat, malgrat que haguem desglossat el seu contingut dins dels apartats que vénen després. El segon apartat és el més característic de l'antropologia del temps, ja que tracta de les percepcions i representacions socials del temps. El tercer apartat sobre el còmput del temps és, malgrat el seu interès, menys estudiat avui que durant el període de l'etnografia clàssica. En el quart punt hem reunit treballs que l'antropologia del temps comparteix amb centres d'interès més arrelats en la disciplina, com són la història, la memòria i, vinculat a aquestes, el lloc com a base de l'antropologia de l'espai i del paisatge, que és la materialització del temps. El cinquè punt reuneix tots aquells estudis que a través del temps aborden l'estructura social en el parentiu, l'economia, la religió, etc. Finalment hem creut que seria útil completar aquesta bibliografia amb altres estudis sobre el temps que d'alguna manera han marcat el pensament contemporani i han influït, per tant, també en l'antropologia.
